


Getting Started

The Versus Headset



Learning the Lights

We recommend fully charging your headset before your first use.






Hold power button for 3 seconds to power the headset on or off.

Before You Begin


- 1. Locate the small container of sensor conditioner provided in the accessories bag.
- 2. With your index finger, apply a thin layer of sensor conditioner to each of the headset's 5 sensors.

Applying conditioner before each exercise session helps secure a consistent sensor connection for an uninterruped session.



1. Download the App

Search "Versus Brain Exercises" in the App Store. Download the Versus app onto your iOS device.



2. Open the Versus App

Find Versus among the apps on your iDevice and tap the app icon.



3. Create Your Account

If you haven't already done so, create an account by selecting "Need an Account" on the login screen.



4. Assess Your Brain

The Versus app will provide a brief tutorial, then guide you through the NeuroPerformance Assessment, which can last up to 22 minutes.




5. Exercise Your Brain

After the assessment, Versus assigns you a personalized stress or focus protocol. You may exercise up to 20 minutes per day, 7 days a week, until you have completed your protocol.



6. Get Assessed Again

Once you've completed your assigned protocol, Versus will assess your brain performance again. You'll see where you improved and where you can continue to improve.



Taking Care of Versus



Don't expose Versus to prolonged sunlight.



Apply only a very thin layer of the sensor conditioner.



Use Versus with clean, dry hair.



Store Versus in a clean, dry environment.

Taking Care of Versus



Do not disassemble.



Do not get Versus wet or submerge it in liquid.



Do not expose to extreme high or low temperatures.



Do not drop Versus. Protect it from sudden impact.
